Online and customer sensitive businesses have long since used coupons to simplify or add onto business. The FASTBIZ network enhances the journey of a customer to include a Fast Track.

What is FASTBIZ?

- **About FASTBIZ when implemented**
- FASTBIZ is a payment mode created and held in printable and electronic forms. FASTBIZ coupons are produced by businesses via Fast Track technology. It is not regulated by a central authority or government.
- FASTBIZ coupons are decentralized and Fast Track facilitators, also termed as Facilitator currency. They are not printed or manufactured in a mint.
- FASTBIZ coupons will not be based on other facilitators like gold, silver, credit notes, etc but on the basis of Fast Track facilitation, where a Surveillance pulse and Risk Survival pulse will regulate the facilitation with risk protection for FASTBIZ network interests, finance interests, “non payment or unacknowledged” transaction insurance, accounting and legal interests.
- FASTBIZ coupons will be produced and used in a FASTBIZ network with a Minima + Maxima Inflexion, that decides the minimum and maximum numbers of coupons..
- This network will manage Fast Track transactions effectively by enabling sign-in and registration into the network. The particulars of registration will not but only include Identify proof, documents / documents identification for Identity proof, self-declaration, Risk 2020 Memorandum of Business Association, Articles of Business Association and many more.

What is FASTBIZ?

- **About FASTBIZ when implemented:** Fast Track transactions on sign-in and registration into the network, will include different processing fees and charges for FASTBIZ coupons.

More about FASTBIZ

- **About FASTBIZ when implemented**
- **FASTBIZ coupons will be a segment or market specific “promote, market and sell” electronic system conceptually based on what was offered by the (not-a-current-currency option) Bitcoins.** The idea is to produce coupons independent of any central authority, transferable electronically more or less instantly with Fast Track technology. The FASTBIZ customer type coupons could be of different types such as Open coupons, Unique coupons, Specific coupons, Social cause coupons, Savings on purchase coupons, Relief and Rehabilitation coupons and Green Zone coupons (where no specific Memorandum of Business Association is needed to facilitate, buy or sell coupons).
- **Today and the near future**
- **The FASTBIZ network can evolve** on a business level or larger level with more and more businesses supporting this mode of transacting. Businesses can use coupons for different Memorandums of Business Association. Interested customers or investors can buy FASTBIZ coupons from exchanges or other sellers.
- There can be FASTBIZ Investment Trusts that take charge of all buying, reinvesting and selling for investors (**not referred to as customers**) who do not want to get into the details, as the FASTBIZ-Actualization-coupons are not used for goods but for Risk 2020 sensitive financial markets by helping businesses produce coupons.

Is FASTBIZ a good investment option for you?

- The gist of the important features could be
 1. It is more **anti-inflationary & sensitive to Risk 2020** and not controlled by any authority
 2. It is **easy to setup** FASTBIZ accounts to become operational in the network
 3. It is **a conservative** view of your account which reveals how many FASTBIZ coupons are associated with it but does not reveal who you intend to transact with
 4. It is a **private mode of investment** and is adept when you do not want to entrust anyone else with your investments
 5. You and **only you own it**
 6. It is **completely transparent**, where every transaction occurring in the FASTBIZ network is stored in a general ledger

Is FASTBIZ a good investment option for you?

- 7. It is **fast** tracked
- 8. Transactions are based on FASTBIZ coupons
- 9. It is **undoable or cannot be cancelled**, meaning FASTBIZ coupons once transacted cannot be got back unless the recipient returns them to you
- 10. It is **trusted and conservative**
- 11. If **you have Fast Track technology you can fast track it**
- 12. While **buying them from an exchange or seller**, you can pay for them via Investment desk options, credit cards, debit cards, hard cash, wire transfer or even other online modalities, all depending upon who you are buying from and where you live or are currently transacting from.

- Investment desk options will enable a Facilitator currency mode for your purchases or buying. The Facilitator currency mode will review how best can FASTBIZ coupons help you, where cash crisis or cash receipt may be a problem. It will design a FASTBIZ wallet for you, which can be initially purchased or availed of on the basis of Risk 2020 certificates.
- 13. You will be able to **send a FASTBIZ coupon or make a payment using it**, the business receiving the coupon will receive the Risk 2020 certificate that formalizes and proves the transaction originated by facilitator services.
- 14. To store your FASTBIZ coupons there will be a FASTBIZ wallet feature, which maybe one of the following varieties:
 - a. A software wallet stored on the hard drive of your computer
 - b. An online web-based service
 - c. A later versioned vault service that provides extra protection to your FASTBIZ investment
